

As we headed into the pandemic, recycling operations were deemed essential businesses as they supply critical raw materials to keep manufacturers in operation. Recycled metal, paper, plastics, and other commodity-grade materials feed critical U.S. manufacturing operations that are producing the rebar, wiring, tubing, transportation, packaging, and other key materials that are needed for everything from construction of new hospitals to the manufacture of new hospital beds, ventilators, toilet paper and other essential supplies needed to keep Americans safe and



the economy running during this critical period.

A number of manufacturing industries that recyclers regularly supply have been officially designated as part of the U.S. “Critical Manufacturing Sector” by the U.S. Department of Homeland Security (DHS), including: primary metals manufacturing (i.e., iron and steel mills and ferrous alloy manufacturing, alumina and aluminum production and processing, and nonferrous metal production and processing); machinery manufacturing; electrical equipment, appliance and component manufacturing; and transportation equipment manufacturing.
